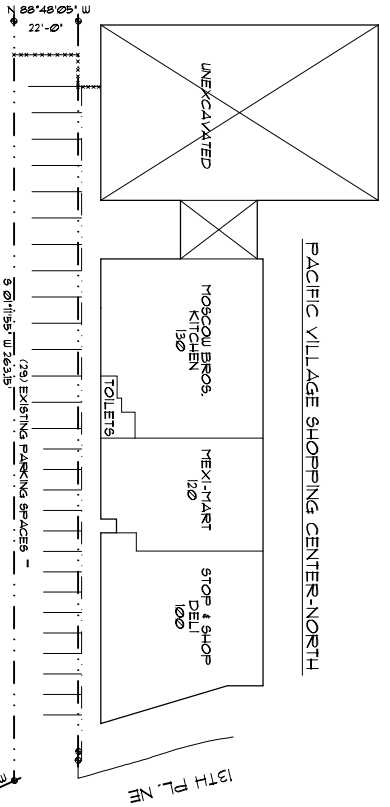
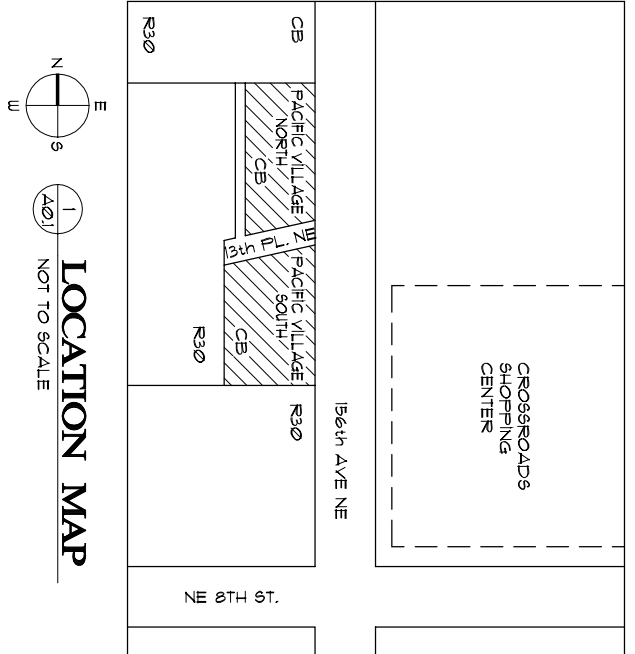
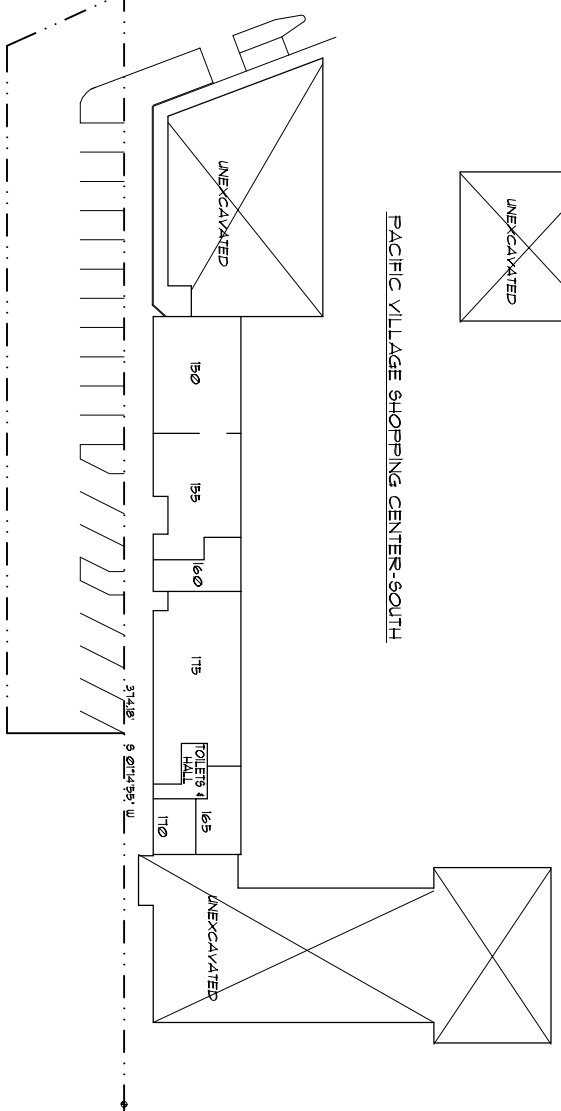
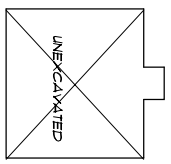
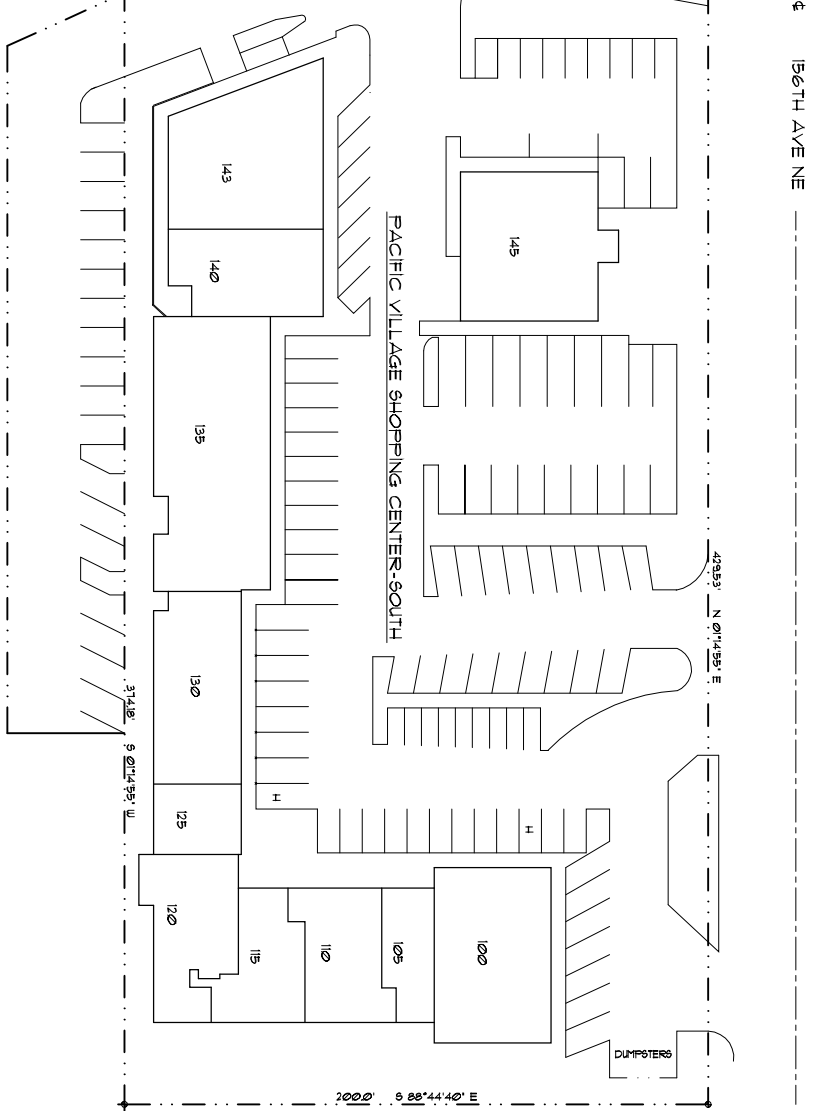


**3 SITE PLAN - UPPER LEVEL**
